The Code of Practice, to which this is a foreword, is prepared in accordance with Regulation 16 of the Environmental Information Regulations 2004 (EIR) and provides guidance to public authorities as to the practice that would be desirable for them to follow in connection with discharging their functions under the EIR.

2 (1) For the purpose of minimizing the introduction of waste into the environment and preventing adverse impacts to the environment and human health, this code requires persons to use environmentally responsible and sustainable agricultural practices when carrying out agricultural operations described in subsection (3).

### Code of Practice for Agricultural Environmental Management

The Environmental Code of Practice for Elimination of Fluorocarbon Emissions from Refrigeration and Air Conditioning Systems, published in 1996 (1996 code of practice), replaced the 1991 code of practice.
