Appropriate privileges to assert in deposition When a question seeks privileged information, it is appropriate to instruct the witness not to answer. In fact, you must instruct the witness not to answer or the privilege is waived. (Code Civ. Proc., §2025.460 (a).)

Confidentiality of a Deposition or not? After a transcript ...

If court reporters are told that all or part of a transcript is to remain confidential, only for attorneys to see, they need to be sure to designate the document, or parts of it, as such. When only certain parts of a transcript are confidential, court reporters should note on the cover of the transcript which sections are designated as such.
